Mo has established the world's first long-term passive income economic system based on the integration of oilfield physical assets and Web3 technology, with the core concepts of "long termism" and "integration of digital and reality". It has developed the www.myoilfield.xyz operation platform, which links oilfield owners and users around the world. Through ultra long oilfield development cycles, dual track asset models (Mo.W.&Mo.G.), and compliant financial infrastructure (Mo.Coin&Mo.Pay), it achieves wealth stability, liquidity, and intergenerational inheritance.

This report will elaborate on the system architecture, economic model, and strategic value of Mo's' Long term Passive Income Economic System'.

Longtermism: A Wealth Engine Across Economic Cycles

1. Ultra long oil field extraction cycle

Oilfield assets: Over 220 billion US dollars of crude oil assets have been signed, with a production cycle of up to 25 years. Subsequently, Mo will add new oil fields, and the corresponding production cycle will continue to be extended. Forming a rolling development with an ultra long cycle.

Kangbo cycle spanning: covering the entire stages of economic expansion, recession, depression, and recovery, resisting short-term fluctuations, and providing intergenerational sustainable preservation, appreciation, and stability for household wealth.

Sustainability of income: Oil field production dividends and platform operating income form a "dual cash flow" to ensure long-term income without interruption.

2. New oilfield expansion mechanism

Global asset acquisition: Continuously integrating highquality oil fields through RWA (Real World Assets) agreements, extending the revenue cycle to over 50 years.

Dynamic equilibrium model: New oil field profits feed back into the ecosystem, offsetting the depreciation risk of old assets.



Passive Income: Dual track Assets and Financial Innovation

1. Mo.W (Digital Oil Well Token) - Anchoring Physical Assets

Asset tokenization: Each oil well issues 10 million Mo. W tokens, which anchor the physical assets of the oil field in a 1:1 ratio and will never be issued again.

Daily dividends: Holders receive a daily production share of corresponding oil wells according to the agreement, and settle dividends daily through Mo Coin.

Enhanced liquidity: an increase in the number of oil wells → an increase in Mo. W flow rate → an increase in trading depth and monetization rate

2. Mo. G (Platform Deflation Token) - Value Capture Core Deflation model: The platform uses 90% of transaction fees and asset management service fees to repurchase and destroy Mo. G, promoting The one-sided upward curve of Mo. G.

Revenue accumulation: Holding Mo. G shares platform revenue dividends (such as DeFi protocol profits), forming a "asset+equity" dual income with Mo. W.



Passive Income: Dual track Assets and **Financial Innovation**

3. MoFi&DeFi - Revenue Doubling Tool Pledge mining: Lock Mo.W/Mo.G to earn compound interest.

Contract trading: hedging crude oil futures and options to achieve risk controlled leverage returns.

Liquidity Pool: Provides liquidity for Mo. W trading pairs, earns commission sharing, and further enhances

Mo.G.

Integration of data and reality: a super interface between Web3 and the real economy

1. Compliance infrastructure: Publicly offered funds registered with the Hong Kong Securities and Futures Commission

Market docking for "old money": Mo collaborates with compliance funds to establish a global channel for individual and institutional holdings of traditional capital.

Dual directional anchoring of assets: physical oil fields → digital tokens (Mo.W) → fund shares, achieving global capital circulation.

2. Mp Pay: a seamless bridge between fiat currency and encryption

Mo collaborates with Visa/Master to support Mo Coin global real-time fiat currency exchange, transfers, withdrawals, and global merchant consumption.

Low fees & high-speed clearing: With the help of Visa/Master network, cross-border payment transaction fees are less than 1%, and the arrival time is less tan 1 minute.

Three Chariots: Ecological Value Flywheel





Mo.G. It is a Mo platform token that operates in the form of deflationary currency, 90% of the transaction fees and asset management service fees obtained during the operation of the Mo platform are used to repurchase and destroy platform tokens that have been put into the market. The sales process of Mo.Wi synchronized, and the unitateral upward curve drives The price of Mo.G has increased.

Mo.W. the digital oil well token of the Mo platform, also known as the asset token of the Mo platform, serves as an anchor for physical assets of oil fields and is a digital twin of oil wells, with 10 million Mo.W per oil well, Never increase issuance, for the holders of Mo.W. continue to benefit, with better liquidity and a higher realization rate of future earnings.

Mo Coin, the dividend token of the Mo patform, is used to disburse dividends from the crude oil production of the digital oil wells. Through Mo Pay and co-branded cards issued with Visa and MasterCard, holders of Mo.W can use the Mo Coin earned from oilfield production dividends to support global cross-border transfers, and they can also withdraw fial currency at any time from ATMs worldwide bearing the Visa and MasterCard logos, as well as make merchant payments and purchass?

Risk Control and Compliance

1.Physical Asset Backing

All Mo.W tokens are regularly verified by independent thirdparty audit institutions to ensure the mapping between oilfield assets and tokens.

2. Financial Compliance Framework

Regulation by the Hong Kong Securities and Futures Commission: Ensures that fund-raising and token issuance comply with international Anti-Money Laundering (AML) and securities laws, guaranteeing compliant operations.

Stablecoin Reserve: Mo Coin is issued with 100% full collateral in fiat currency, with periodic public audit reports.

3.Internet of Things (IoT)

Data from exploration, drilling, production, storage, pipeline transportation, and sales is independently uploaded to the blockchain. The entire operational process of Mo.W is verified using Zero-Knowledge Proof (ZKP) technology to ensure controllability, credibility, and visibility. Sensor data deviations from on-chain records are maintained at <1%, and any non-compliant operation automatically triggers smart contract alerts.

4.Insurance Fund

The Mc platform reserves 10% of its revenue as a risk reserve for Mo.W. In extreme market conditions, this reserve is used to initiate a Mo.W token buyback.



Strategic Vision

Mo, powered by the triple engines of "Crude Oil
+ Web3 + Finance," redefines the long-term passive income economic system through the three "driving forces" of Mo.W, Mo.G, and Mo Coin:

Short-term (1-3 years):

Become the leader in the oilfield RWA sector with entrusted oilfield assets exceeding 1 trillion USD.

Mid-term (5 years):

Build a global ecological network spanning the energy, finance, and consumer sectors.

Long-term (10+ years):

Establish "intergenerational family wealth transfer" as the global standard for wealth growth.
